ACCREDITATION

The ECCL press centre applies the same accreditation policy in force at the Council's Justus Lipsius building in Brussels.

Journalists and technicians are granted access upon presentation of:

- A valid national identity card or passport, AND
- Interinstitutional press card issued by the Commission (yellow card), OR
- Council six-month badge, OR
- A letter signed by the editor-in-chief of the media organisation, confirming the professional status of the media representative and his/her assignment to cover the event on behalf of the same media.

PRESS CENTRE

The press centre is located on four levels (-2, -1, 00 and +1). The press room is located on level 00, the national briefing rooms on levels 00 and +1.

Press conferences and national press briefings will be announced on internal screens.

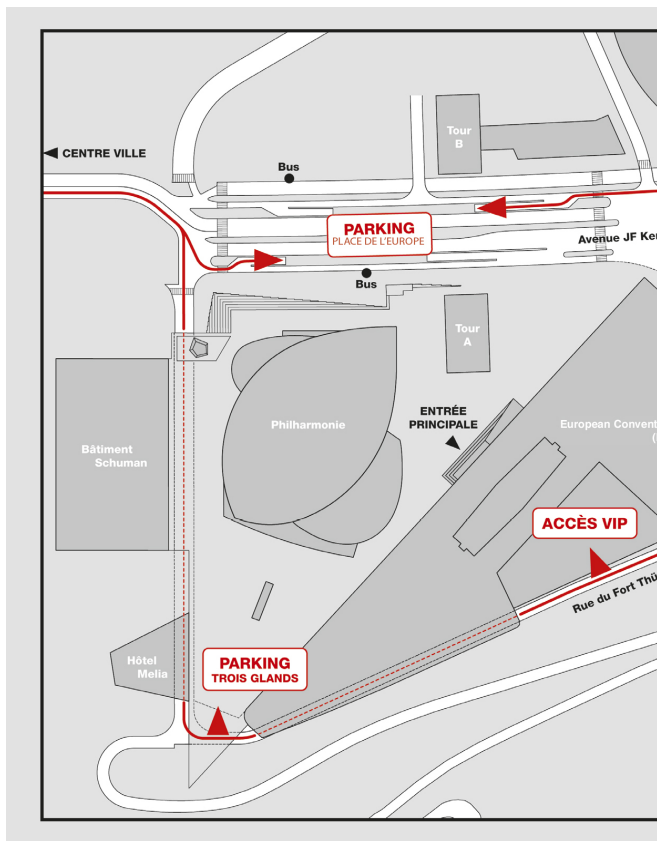

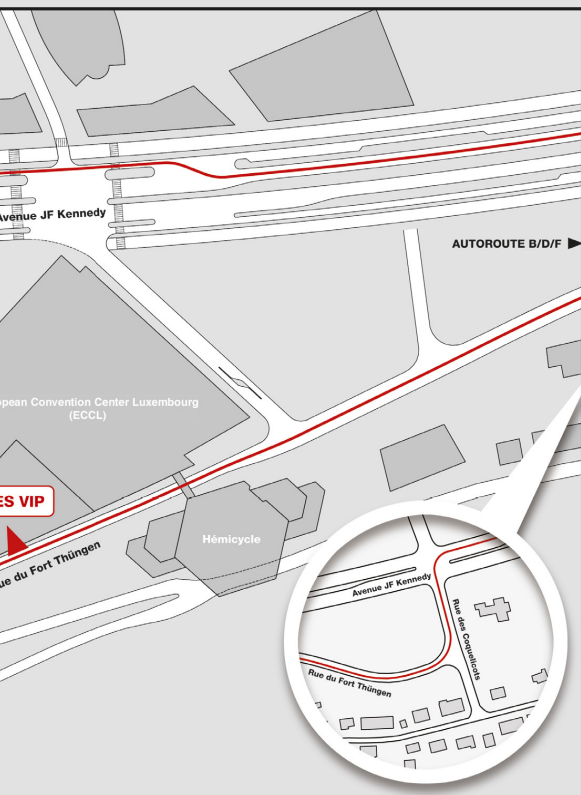

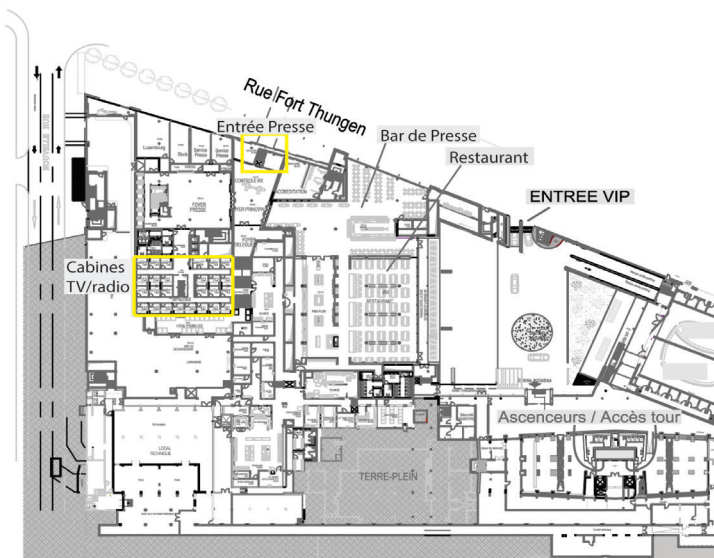
FLOOR PLANS OF THE EUROPEAN CONFERENCE CENTER LUXEMBOURG

1. ECCL PRESS CENTRE





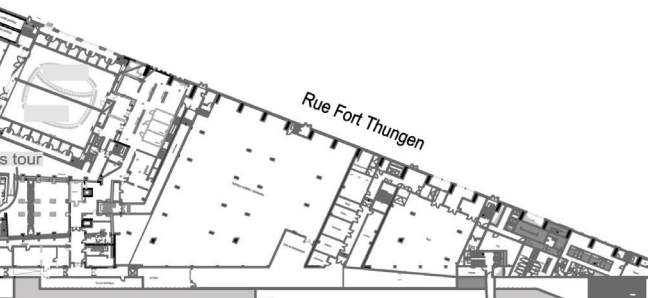
2. ECCL LEVEL -2

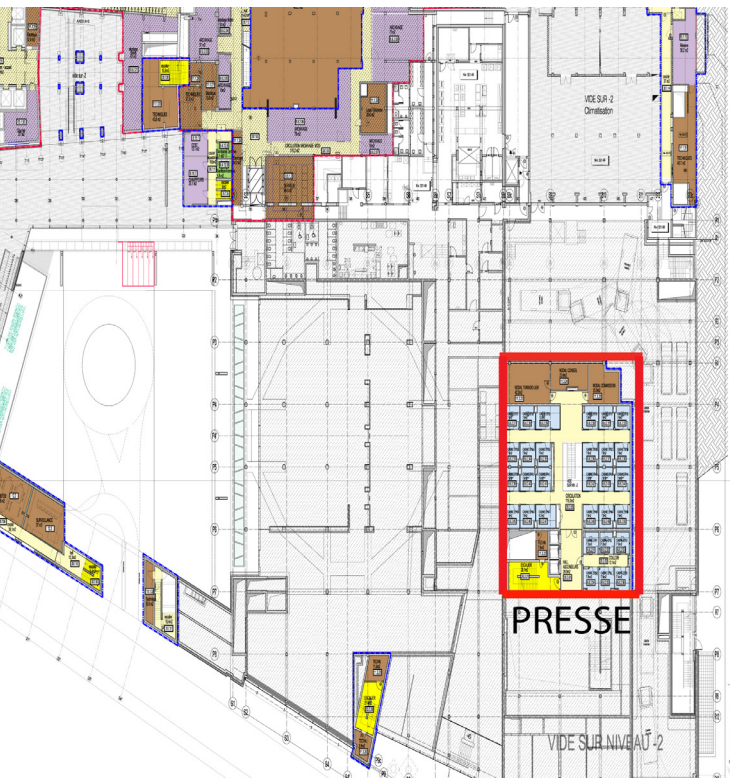

3. ECCL LEVEL -1

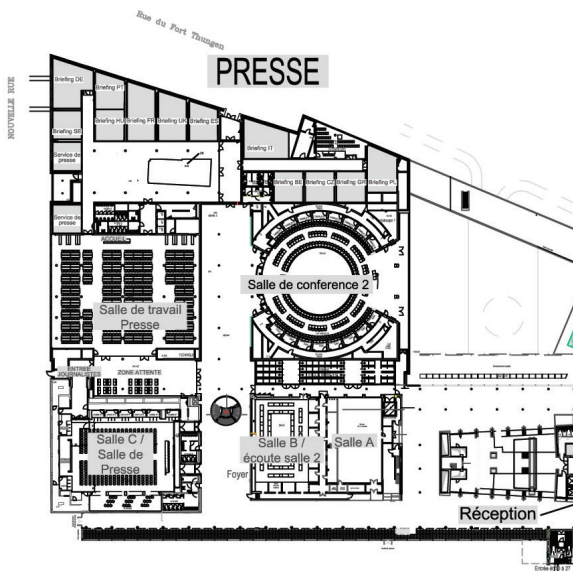

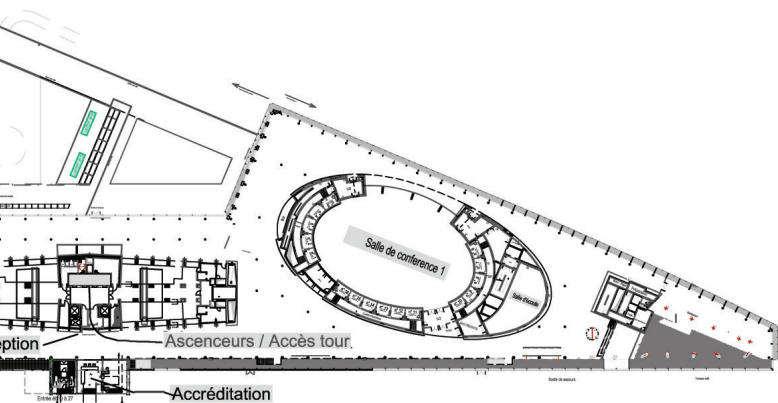


4. ECCL LEVEL 00

 - 2 camera platforms (at centre and back of the room)

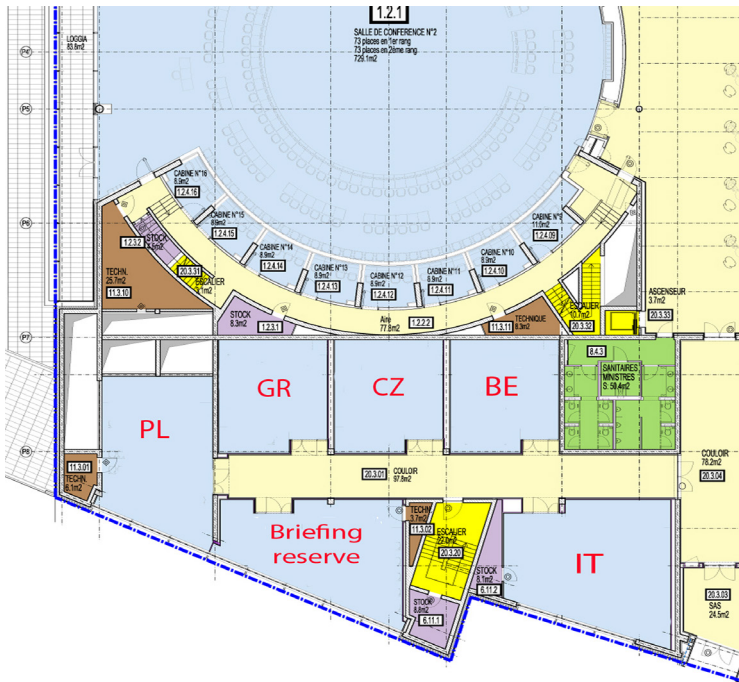

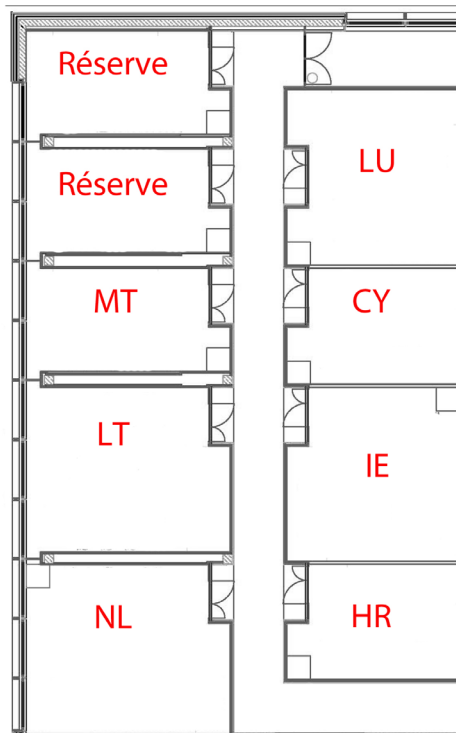

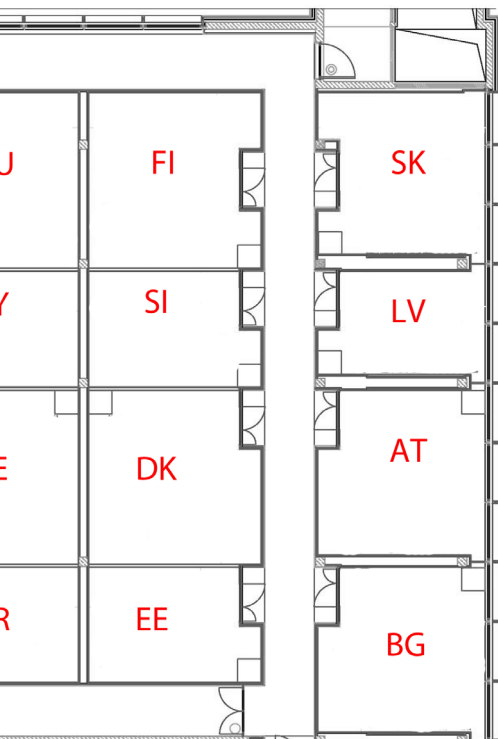


6. ECCL LEVEL +1 - BRIEFING ROOMS
